Public comments regarding agenda items may be made during the Public Forum or when the agenda item is called. All comments are limited to three (3) minutes, and time may not be saved, transferred, or assigned. All speakers are expected to maintain proper decorum. Threats, personal insults, cursing, or profanity may result in forfeiture of the speaker's remaining time. Citizens must complete a written request to speak and furnish the request to the City Secretary at least ten (10) minutes before the meeting.

- a. Citizen comments on non-agenda items.
- b. Citizen comments on agenda items.

6. Discuss, consider, and take possible action regarding the Police Department contract with Peacemaker, with a remaining contract amount of \$10,435.00.
7. Discuss, consider, and take possible action regarding the Police Department contract with Halo, with a remaining contract amount of \$5,524.00.
8. Discuss, consider, and take possible action regarding the Utility Data Systems municipal court system contract.
9. Discuss, consider, and take possible action regarding the Geotab contract, in the amount of \$3,841.90.
10. Discuss, consider, and take possible action regarding the Function4 copier contract and the following payment options:

- a. \$4,531.83 for the Police Department copier only; or
- b. \$8,621.56 for the Police Department and City copiers.

11. Discuss, consider, and take possible action regarding the removal of Teresa Allison from the CD at Lamar National Bank Account ending in 22811 and adding a new signer.

12. Finances.

a. Discuss, consider, and take possible action regarding the Treasurer's Report.

13. Adjourn.

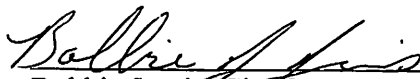
